Western Psychiatric Institute and Clinic, Office of Education and Regional Programming (OERP), is hosting a ten-part series on recovery with individuals with co-occurring disorders (mental illness and substance abuse disorders). This training was developed in conjunction with the Office of Mental Health and Substance Abuse Services (OMHSAS) and the Bureau of Drug and Alcohol Programs (BDAP) and will provide core competency-based training for professionals working with this population.

Each section is being offered as a one-day seminar with each session building on the information from the previous training. Participants can register for the entire series or individual workshops, depending on which best suits their educational needs. Seminars will begin in April 2008 and will be held each month for 10 consecutive weeks at Mayview State Hospital Regional Conference Center. Instructors will include faculty and staff of Western Psychiatric Institute and Clinic and community professionals from the mental health and substance abuse field, all of whom have considerable work and teaching experience related to co-occurring disorders. Professional continuing education certification, including Certified Addiction Counselor/Certified Co-Occurring Disorders Professional (CAC/CCDP), and Licensed/Clinical Social Workers, Licensed Professional Counselors, Licensed Marriage and Family Therapists (LSW/LCSW, LPC/LMFT) credits, will be offered for all programs.

CO-OCCURRING DISORDERS: CONCEPTS AND APPROACHES

Program Description:

This seminar provides definitions of integrated disorders and programs and presents an overview of how to approach the topic by using organizing principles and tools. It examines the scope of what practitioners working with persons having co-occurring mental and substance abuse disorders need to establish basic competency in this area. It also explores the historic rationale for splits in service provision and the necessity for integrating approaches. Specific interventions will be discussed, as will a review of the full array of programs and services that may be needed by persons with dual or multiple disorders, and reviews of the terms in the Co-Occurring Competency Bulletin released conjointly in February 2006 by the Department of Health and the Department of Public Welfare.

Educational Objectives: At the conclusion of this program participants should be able to:

- define “co-occurring disorders” and what constitutes “integrated approaches” to working with persons having CODs
- examine major concepts and approaches currently in the literature
- review personal attributes and skills needed for effectively working with persons with CODs
- explore the contents of Pennsylvania’s COD Competency Bulletin
- identify resources useful in gaining more knowledge about effective practices in COD

Program Description:

This seminar examines the importance of creating a working relationship with people beginning treatment, their family members, and other support persons. Participants examine their own engagement skills and review principles of strengths-based and culturally-competent practice. An overview of change theory and motivational interviewing skills is presented, as are general attitudinal and behavioral attributes needed in order to be welcoming, respectful, and demonstrating practice conducive to sustaining a recovery-oriented environment.

Educational Objectives: At the conclusion of the program, participants should be able to:

- describe components of a welcoming environment and its opposite
- identify specific behaviors that demonstrate welcome and respect
- review basic principles and components of strengths-based practice, change theory and Motivational Interviewing
- self-evaluate personal strengths and needs regarding engagement skills
- practice engagement skills and supporting setting

Program Description:

This seminar builds on material discussed in the Introduction and Engagement seminars. The first half of the course examines screening and assessment needs and means of acquiring the data needed for useful clinical decision making. The second half provides an overview of the types of treatment approaches that may be most useful for persons with differing disorders and levels of symptom severity, including examination of cultural differences, environmental supports and stressors, and peer supports.

Educational Objectives: At the conclusion of this program, participants should be able to:

- explain components of assessment and the assessment process
- identify attitudes and skills needed by those conducting COD assessments
- review some existing treatment approaches found useful for persons with different diagnostic combinations, change readiness, and levels of symptom severity
- describe means of identifying, locating, and linking other needed supports
- discuss cultural elements that must be considered in selecting approaches to assessment, treatment, and acquiring other supports

Program Description:

This seminar provides an opportunity for participants to review the principles of collaborative treatment planning, including working from the comprehensive assessment; using stage of change theory; identifying and mutually setting long- and short-term goals; identifying steps for accomplishing goals, the persons responsible, and a defined time line; and reviewing and altering such plans when necessary. Progress tracking is reviewed, including how to write clear and concise notes, and the principles for what to include and who may review them. Building on previous seminars, this course focuses on effective engagement and treatment principles and the practices of writing and reviewing plans and related documentation.

Educational Objectives: At the conclusion of the program, participants should be able to:

- review the principles and processes which support thorough and accurate assessment and diagnosis, including cultural diversity issues
- explore each step in the treatment/service planning, its rationale, and the similarities and differences in service and treatment planning
- discuss the use of change theory and motivational interviewing in “planning to plan”
- define the components of integrated planning from a recovery and strengths perspective, including the principles of collaboration and choice
- identify means of writing brief and useful progress notes and using them with the person to assess progress and use strategies that support movement toward positive outcomes

GROUPS AND GROUP SKILLS IN WORKING WITH INDIVIDUALS WITH CO-OCCURRING DISORDERS

Program Description:

This course will briefly review principles and skills needed in developing specific kinds of group modalities and group goals, norms, and processes. Psychoeducational and skills-based groups will be a major focus. The needs of persons with various combinations of dual and multiple disorders will be discussed, and means of matching group processes and leader activities to the specific needs of group members will be presented. A discussion of historical similarities and differences in approaches to individual and group therapy between mental health and substance-related treatment programs will be included, along with ideas for how to synthesize and use best practices found in each.

Educational Objectives: At the conclusion of this program, participants should be able to:

- identify multiple uses of group approaches and potential benefits and risks of group membership, including peer support groups
- examine diagnostic combinations and individual characteristics that may suggest the need for using individual vs. group approaches to provide interventions suited to the person's stage of change
- identify components of psychoeducational groups and when they might benefit the person with dual or multiple disorders
- describe at least one model of a skills-teaching group, including its components and when it might be most useful to a person with dual/multiple disorders
- outline some means of personally improving proficiency in leading or providing support for at least one type of group

Program Description:

This course will review basic classes of addictive and non-addictive psychoactive medications, their uses and limitations, potential major side effects, and possible serious interactions. Actions of the medication in the brain will be presented in a simplified form, as will absorption and release in the body. Newer classes of antipsychotic and antidepressive agents will be discussed, as well as the use of some references for information.

Educational Objectives: Upon completion of this program, participants should be able to:

- identify classes of psychotropic medications, including their uses and risks
- examine current best-practice techniques for prescribing and monitoring psychotropic medications, including collaborative work with the person taking these medications
- list potential interactions of classes of psychotropic medications with alcohol and street drugs, including level of risk
- discuss various means of working with individuals and significant others to support knowledge-based choices about medications, including the possible effects of culture on choice

Program Description:

This program consists of two components: Comprehensive Approach to Violence and SAFE Crisis Management. Comprehensive Approach to Violence teaches assessment and prevention techniques as well as crisis management skills. It helps employees to assess whether a potentially violent situation is developing and how to prevent a crisis. SAFE stands for "Safe Alternatives For Emergencies" and teaches physical techniques for movement, escape, and passive physical restraint that are effective and safe for staff and the aggressor. SAFE does not rely on speed, strength, or surprise; instead, participants learn to use natural body movement in effective ways.

Educational Objectives: At the conclusion of this program, participants should be able to:

- identify a system perspective as an approach to understanding violent behavior
- identify a frame of reference for working with the client who has a potential for violence
- identify the impact of the role of self in the management or escalation of a crisis situation
- develop environmental awareness related to personal safety
- identify skills and activities to use during a crisis

Program Description:

The focus of this seminar is on the internal process of recovery and relapse prevention, and the stages and possible supports needed. The types of structures and uses of psychiatric rehabilitation in facilitating recovery and relapse prevention will be discussed, including providing needed skills and alternative coping strategies. Different forms of self-help will be discussed in detail, as will the necessity for the availability of choices.

Educational Objectives: Upon completion of this program, participants should be able to:

- review several research-based models of recovery and relapse prevention
- explore the ways in which different forms of interventions (e.g., 12-step programs, drop-in centers, clubhouses, psychoeducational groups, vocational rehabilitation) can support personal recovery
- examine the values and principles of psychiatric rehabilitation and the various programs that put these values and principles into action
- identify ways of working with individuals having dual or multiple disorders using collaborative rather than "expert" means of relating and supporting active choice
- discuss the importance of hope to both the person with co-occurring disorders and those who provide treatment and services

- review major differences in law and regulations governing mental health and substance-related treatment agencies and practitioners, and the current effect on integrated practice
- identify areas of operation within a managed care environment that may present specific challenges to ethical practice, including ways to reduce such risks
- discuss advocacy for needed treatment approaches and supports as central to the ethical-practice

Program Description:

This seminar will examine the centrality and impact of families of origin and other constructed "families." It will explore means of working in partnership with family members rather than continuing cycles of blame and misunderstanding. The importance of creating a welcoming atmosphere will be emphasized. The particular and valuable expertise of family members will be discussed. "Enabling," "codependency," and "rescuing" are among the terms to be reviewed and reframed. Connecting families with systems for meeting multiple needs will also be discussed.

Educational Objectives: Upon completion of this program, participants should be able to:

- examine the role and dynamics of the family in terms of human development, culture, and society
- explore both the benefits of and barriers to working in partnership with family members and significant others
- identify ways in which treatment and service providers may bring personal biases into work with family members/significant others, including the feelings and thoughts that support these biases
- discuss steps needed for meeting family members/others in welcoming and respectful ways and involving them as collaborative team members
- review means for acknowledging both helpful and unhelpful behaviors on the part of family members/others without blaming, and for offering alternatives for reducing risks to the person having co-occurring disorders and the family
